INFORMATION ABOUT PROCESSING DATA

The Consulate General of Hungary in Toronto, as the controller, commits to process the data provided in this survey in accordance with the General Data Protection Regulation of the European Union (Regulation 2016/679 of the European Parliament and of the Council of 27 April 2016, hereinafter referred to as the General Data Protection Regulation or GDPR) and Hungarian law.

The controller commits to ensure the security of the data it processes.

The controller shall use the data provided by the person concerned in this survey according to the purpose limitation and solely for the purpose of organising the extramural consular days and maintaining contact. The data processed may be recognised by the controller and its employees. The controller shall not disclose or make available the data to any third party who is not entitled to access the data.

The legal basis for processing is the voluntary consent of the person concerned pursuant to Article 6(1)(a)of the GDPR. The person concerned is entitled to withdraw his/her consent at any time by sending an email to consulate-tor@mfa.gov.hu. The withdrawal of consent shall not affect the lawfulness of the processing based on consent prior to its withdrawal. The controller shall keep the data indicated in this survey for 2 (two) years from the date of submission. The person concerned shall have the right to request in writing the Controller to delete the data indicated in the survey.

The person concerned's rights in relation to data processing are set out in Articles 13 to 18 and Articles 20 to 22 and Articles 77 to 82 of the GDPR.

The person concerned may take legal action against the controller if he/she considers that the controller or its employees are processing his/her data in breach of the data processing requirements laid down by law or by the General Data Protection Regulation of the European Union. The competent court to hear the action is the court for the place where the person concerned resides or is domiciled.

The person concerned, in order to assert his/her rights, is entitled to lodge a complaint with Nemzeti Adatvédelmi és Információszabadság Hatóság (1055 Budapest Falk Miksa utca 9-11, website: http://naih.hu; postacím: 1396 Budapest, Pf.: 9.; phone: +36-1-391-1400; fax: +36-1-391-1410; e-mail: ugyfelszolgalat@naih.hu) on the grounds that a breach of rights has occurred or is imminent in relation to the processing of his/her data.
